About processing of personal data

As part of the membership of the Swedish Federation of Green Employers, a collection of membership data is made annually. When collecting these data, members are also asked to provide personal information about contacts at the company, mainly details such as name, e-mail address and position. The collection of these data is necessary for the Swedish Federation of Green Employers to be able to fulfill its commitments to its members.

The person who submits personal data about others is required to make sure that consent has been obtained for disclosing this information. Personal data is processed in accordance with applicable laws and the Swedish Federation of Green Employers is also working actively to prevent your personal data from being misused, spread, lost, altered, destroyed or in any other way accessed unauthorized.

Personal data may be processed in systems that are available to the entire Confederation of Swedish Enterprise with its in-house member organizations. According to the Statutes (§3), The Confederation of Swedish Enterprise shall be a unified entity and the common systems are the part of creating this unit. However, only those who have access to these common systems are authorized users.

The Swedish Federation of Green Employers manages personal information to provide members with information about news, events and similar. The data may also be processed to develop the business. In addition, the Swedish Federation of Green Employers may process personal data to comply with statutory obligations.
